Completed Carbon Reduction Initiatives

- New laminator installed, projected to reduce material consumption and waste generated.
- Fleet ID Ltd. has transitioned company vehicle to battery electric.
- Two electric vehicle chargers installed on site.

Planned Carbon Reduction Initiatives

Our environmental action plan commits us to the implementation of further measures which we anticipate will reduce the carbon intensity of the organisation, such as:

- Engaging with key products and materials suppliers on their sustainability credentials and availability of lower carbon products.
- Ensuring low carbon purchasing throughout the business.
- Continue transitioning to materials that generate less wastage where possible.
- Monitoring of material innovations to identify opportunities to reduce the environmental impacts of our product offering.
- Facilitating access to low-emission vehicles for our staff.
- Engaging with our landlord on transitioning to a deep-green electricity tariff.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 006 and associated guidance and reporting standard for Carbon Reduction Plans.
